

# 1. CORRECT NAMES/DATES/TIMES/FLIGHTS/CAR/HOTELS

Reference the booking confirmation from your travel advisor and verify all information is correct. Jetsetters International will not be responsible for omissions or errors if not brought to my attention immediately. Payment must be received by the due date to avoid vendor cancellation.

Verify the following applicable information for those boxes have been checked:

- o Correct legal names
- o Dates
- o Flight times
- o Hotel and/or car rental information (if applicable)
- I have read the penalties that apply
- I am aware of what testing and documentation is required to access my destination
- Passport validity
  - \*\*Valid for at least six months after you return home
  - \*\*Has (2) or more empty pages

## 2. DOCUMENTATION

U.S. citizens traveling to any destination outside of the United States will be required to present a valid U.S. passport. Passports must be valid for 6 months past the return date. Some countries require a visa for transit or entry. Passengers are responsible to ensure that they have all the proper documents for entry. All names on documents must match the legal name on your photo I.D., and travel document information must match tickets. Please check the State Department website at https://travel.state.gov for further information. Immunizations may also be required. Failure to comply with these regulations may result in denied boarding, denied entry, and/or government-imposed fines. If you are a citizen of another country, there may be additional requirements. Check with the nearest consulate or embassy of the destination you are traveling to and find out the entry requirements for non-U.S. citizens.

#### **3. TRAVEL INSURANCE**

Jetsetters International recommends that you purchase travel insurance to protect your travel investment. We only *offer* travel insurance; we do not *sell* travel insurance. Jetsetters International does not file private insurance claims and are the sole responsibility of the client.

### **4. FEE DISCLOSURES**

The addressee of the invoice and/or travel documents will be the only recipient of invoices and is solely responsible to convey all information to all listed passengers. Passenger names must reflect full legal names as appears on passenger's valid passport. Notify your travel advisor immediately if any corrections are needed. Suppliers may charge substantial fees plus applicable fare increases for any name changes. (For immigration and customs purposes it is essential that this information is accurate. Boarding airplanes may be denied if the information is inconsistent.) There is risk of cancellation by the supplier if the final payment is not received on time. Be aware that cancellation penalties may apply prior to the final payment date.

Jetsetters International reserves the right to issue a Future Travel Credit in lieu of refunds at its sole discretion, in the event of cancellations caused by events or circumstances beyond its reasonable control, including but not limited to acts of governments, epidemics, pandemics, medical quarantines, severe weather conditions, war or terrorist acts or threats. The Future Travel Credit is not transferrable, non-refundable, and has no cash value. It is the responsibility of the client to pursue rebooking and initiate a change in writing via email. FTC is issued with expiration dates and must be used prior to expiration. Standard change fees, planning fees and cancellation policies apply to bookings made with FTC. Jetsetters International does not recall commissions on cancelled bookings from 2020 up to date. In the event a refund or credit is approved, the total will be subject to cancellation fees and NET rates less a 3.5% credit card fee.

Cancellations made after final payment are non-refundable. All payments are nonrefundable but may be applied to future travel at the discretion of the tour operator and Jetsetters International. *Plan to Go* retainers are paid at the start of the planning process. Fees will be accrued for cancellations and revisions to deposited itineraries. Amounts will be deducted from PTG retainers or charged to the client directly.

### **5. AGENCY DISCLAIMER**

Jetsetters International offers retail travel services to customers, which are provided by separate and independent vendors of travel services. Jetsetters International does not operate, control, or otherwise provide the services of the independent travel vendors. Jetsetters International an independently owned and operated agency, acts solely as a general booking agent on behalf of the customer, for the purpose of processing bookings and reservations with various cruise lines and travel suppliers. Jetsetters International has no control over the travel suppliers, the fares charged for services, their policies and procedures, change in itineraries, the scheduling of their services, or their methods of providing services. Therefore, Jetsetters International shall not be liable or responsible, and is released of responsibility and liability, for any delay, inconvenience, loss or damage for personal or property injury, to any Passenger resulting from breach of contract or any acts or omissions on the part of any travel supplier, cancellation of any service by a travel supplier, any refund due from a travel supplier, any terrorist activities, civil or labour unrest, mechanical or construction defects or failures, diseases, local laws, climatic conditions, or any other cause.

I accept that Jetsetters International is not responsible for, nor will I attempt to hold it liable for, any injury, damage or loss I may suffer on account of any conditions, actions or omissions that are beyond its reasonable control.
